

A New View Spring Contest 2020: Rules and Regulations

- 1. No purchase is necessary to participate in this promotion; you do not have to submit to a sales presentation. Void where prohibited by law, rule, or regulation.

- 3. You may enter this promotion by completing the entry form located at our web address residentialhs.com or by in person during normal business hours of Monday through Friday 8 am to 5 pm at 523 N Ella Rd, Spokane Valley, WA 99212. No more than one entry per household is allowed. Residential Home Solutions is not responsible for any illegible, misplaced, incomplete forms, damaged or late entries. The address listed on each entry form must be the address where the prize is to be installed if such entry is selected as a winner. If the entry is on the web, contest rules box must be checked. If the entry is at an event or our showroom, contest rules box must be checked. A copy of contest rules will be at each event and at our showroom.
